**DRAFT MINUTES** of the **Full Council Meeting** held on Monday 6<sup>th</sup> January 2025 at 7.00pm in the Library, Hungerford.

**Present:** Cllrs, Simpson, Fyfe, Keates, Winser, Cole, Coulthurst, Reeves, Alford, Hudson, Montgomery, Carlson. **Also present:** Representatives from Penny Post, the Adviser and Newbury News. Several members of the public including representatives from local businesses and the Chamber of Commerce. District Cllr Denise Gaines (DG) from West Berks Council (WBC)

In attendance: Town Clerk, (TC) and RFO.

**Police report.** (refer to our website for the full report). The Mayor read out the report and added she had been informed that due to a cut in funding from central government Hungerford are potentially at risk of losing our Sergeant and instead Hungerford & Downlands would be grouped with Thatcham. The Mayor requested support of the council to rally against this decision

**ACTION:** The Mayor will bring this concern to the attention of the MP and Police & Crime Commissioner.

abstention.

#### **Outcome of actions:**

The missing cobbles in school alley have been replaced properly and the tarmac repaired. There is a larger area of tarmac nearby that needs improving.

The Clerk has applied for a Members Bid for flower tubs in the High Street. The concerns of members of the public about the lack of visibility of the pedestrian crossing in Charnham Street have been passed onto WBC. The Clerk has fed back HTC's responses on the budget consultation. WBC have been asked if the Hungerford NDP can be added to any extraordinary agenda to be signed off rather than wait until the end of March. This will be done if possible. In the meantime, Cllr Hudson advised some more work is required to be done to the NDP following the change to the National Planning Policy Framework (NPPF). (It has since been confirmed this is not necessary)

**ACTION** Clerk continues to chase progress with costs for cleaning High St footway.

**ACTION:** Clerk is making necessary amendments to policies following the dissolving of the staff committee.

FC2025004 Receive Mayor's Report - See attached report.

**FC2025005** Receive District Councillor's Reports – DG advised the budget consultation has now finished, and the number of responses could have been better. The review of the NPPF (National Planning Policy

Framework) has resulted in a rise in housing targets from 495 to 1070 new homes in West Berkshire per year. The current Local Plan Review will not include the new numbers, and WBC will instead need to do a refresh of the new policy. Other policies are being put in place like C02 and flooding, which will be universal for all areas making creating local plans much more efficient. Our NDP housing numbers will remain unchanged.

DG explained: West Berks is a small unitary council so may need to join with others as part of the devolution changes however this is not likely to happen in the near future. WBC are taking in rough sleepers during the cold period. Atherton Crescent has been resurfaced and Fairfields Close is also being done. Salisbury road is to be closed for gas leak repairs and the diversion is via Marlborough. Clerk to send the closure details to send to DG as WBC need to ensure that there is sufficient signage

in place to avoid lorries diverting along residential roads.

Marlborough TC is looking to deprioritise the route through their town. Concern was raised about the effect this would have on Hungerford. DG thinks it is very unlikely that there would be an agreed diversion on an A road.

**FC2025006 Health & Safety – Receive any complaints or concerns.** Concern was raised on facebook that some of the main roads were not being gritted. It was confirmed this is infact incorrect as Atherton Hill and the A4 are both included on the gritting route. The gritters come from Chieveley and usually grit overnight.

FC20250011 Consider withdrawing Town Council's involvement with the Town Centre Steering Group (TCSG) as it currently stands. (This item was taken after item FC2025005 due to members of the public present) The Mayor has circulated her report to everyone. Cllr Cole commented that he

disagrees with the Mayor. They both read out their reports (please see attached both reports)

DG has advised WBC that this proposal is being put forward and they are a bit disappointed. She

added that there could be possible funding available in the future through CIL and once the Hungerford NDP is in place HTC will receive 25% of CIL money. Unfortunately she thinks it is unlikely the £3,000 funding can be passed to HTC.

A representative from the Chamber of Commerce commented that the TCSG meetings had not achieved anything and they will be withdrawing. It is positive however that the retailers now have a group within the Chamber of Commerce. They will be foccussing on other issues such as council tax. A representative from the retailers confirmed that although they were supportive of some sort of town square they will be withdrawing from the TCSG.

The Mayor added it can be revisited when funds allow.

# **New Year Challenges**

On reading this I was very concerned about Hungerford's neighbourhood police team and what implications this could have locally.

I have now been informed (further details following) that announcements have been made, resulting in West Berkshire losing a neighbourhood Sgt, that Neighbourhood is Hungerford's, and will be a huge blow to our community. The Thatcham Sgt will now look after Hungerford & Downlands as well as Thatcham, this is a huge area to cover and will result in Hungerford getting the worst outcome. I have promised the team I will be contacting the PCC and Thames Valley to try and overturn this decision. There are further changes due to be announced. Sgt Dan Lond has made a significant contribution to Hungerford, and we've seen some real change under his leadership. I know central government funding hasn't been granted but there must be an alternative solution so that our town (furthest West) continues to be policed sufficiently. Thames valley police need to consider their staff and listen to the communities.

We have a continuing amount of drug related crimes in the town and several pockets of anti-social behaviour. The elderly residents in Redwood House have spoken to me over Christmas, they are scared, following two incidents where armed police officers were on site dealing with someone who shouldn't have been on the site. They shouldn't have to be dealing with this behaviour in their retirement years.

I understand there was a large brawl, with number of people involved at the top end of town on New Years Eve. Police officers were called to site as well as the ambulance service. This again is right outside a residential area, housing young families. Hare coursing is also on the increase and needs specialised policing teams to root them out. Hungerford understands we may not have the highest numbers of crime, but those we have are no less distressing when they occur. I think the whole town would agree, because of our location it is vital to have a neighbourhood police team here. I am convinced that having a police Sgt based as far as Thatcham will have significant detrimental impact on the town. Dan and his team will have my full support. I hope HTC will do all it can to raise awareness.

# Town Centre Steering Group (TCSG) - Cllr Simpson

Following on from HTC's December full council meeting. I would like to share my thoughts on possible next steps. I have collected views, opinions, and sat with my own thoughts over the Christmas break.

HTC has held a place on WBC's TCSG for about a year, responsibilities were devolved to HTC when funding and resources from WBC were reduced. Despite our very best efforts, it has become almost impossible to move forward.

I believe we were all there to achieve something positive for Hungerford. Every group member was there because of their expertise, position or to represent an organisation. However, the TCSG has been unable to work together without disagreement. Every member protecting their own interests. This isn't a negative, however it has made it hard to agree a collective way forward without a great deal of compromise.

WBC were unable to bring enough funding to the table in-order to move the project ideas forward. At the 11<sup>th</sup> hour a sum of £3k has been found to help this process (largely due to James). Unfortunately, this sum is not enough to bring the ideas forward, leaving HTC needing to find three or four times this, to do a topographical survey, drawings and a public consultation on our ideas.

Living in the town for as long as I have, I feel residents would be more interested in the grass being cut, dog poo bins remaining, and the health and well-being of residents being a higher priority than a future ambition, which may or may not be delivered for which there is currently no funding. HTC has proved we can punch above our weight and deliver huge projects. The Croft activity centre, the skatepark, Library, HYCC, to name just a few.

As I've said this hasn't been easy for any of us, damaging long standing relationships and good working practices is not something any of us signed up for.

I will be proposing on Monday that HTC should withdraw our support and management from the TCSG with immediate effect. Instead concentrating on the many town aspirations, on-going projects, and potentially some devolution services from WBC.

I would like WBC to consider passing the £3k of available funding to Hungerford town council, so that we can continue to build the pot for future town improvements. Working from the short list of more achievable goals from the TCSG list. I believe these projects are better managed through HTC, consulting when we need to with stakeholders.

# **Town Centre Steering Group (TCSG) Report – Cllr James Cole**

Thank you, Helen.

The key things to me are that

- TCSG has been a West Berks Council committee to advise West Berks on real needs for improving Hungerford's Town Centre.
- It was created because people of Hungerford made the <u>effort</u> to respond to a West Berks-inspired survey done by some West Berks-appointed consultants. There was a much higher response rate from the town than we would normally expect for such a survey
- Some of us came to dread turning up to TCSG meetings because the meetings became so toxic. I
  don't propose discussing the toxicity this evening
- TCSG is a mechanism for getting money to Hungerford, but it was started at a time when West Berks
  was running out of money
- Most High Streets are dying political parties are not the primary cause but one newspaper claims
  that High Street shop closures are predicted to climb by a third after the current government's tax
  raid. This problem is not going away.

Apart from the lack of money nothing has actually changed from the original aims. It is my view that

- The time will come again when there is money to spend
- There remains a responsibility to look after the wishes of the people of the town that made the effort to respond to that survey
- The major aggravation in what the TCSG was trying to do was the so-called Town Square. It was and remains a sensible idea to improve the centre of Hungerford. Adrian Gilmour's survey actually showed that the traders are in favour of a Town Square. There will be an acceptable way to do it.
- It is anti-democratic to ignore the wishes of the town as a result of the demands of a very small group with heavily vested interests

It comes down to "do you throw the baby out with the bathwater?"

There was always an overlap between TCSG and this council – I don't see the overlap as a real issue and I do think the mechanism is worth retaining

I will not vote for this proposal.
