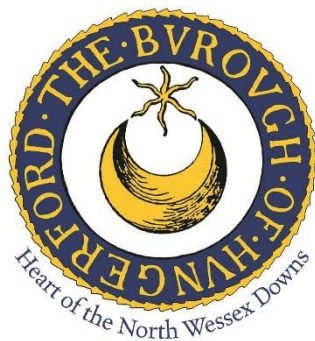

MINUTES of the **Environment and Planning Committee** meeting held on Monday 8th July 2024 at 7.00 pm in the Library, Church Street, Hungerford.

Present: Cllrs Fyfe, Keates, Hudson, Simpson, Carlson, Cole, Armstrong and Coulthurst.

EP2024035 Approval of Minutes of the Meeting held on Monday 10th June 2024 and update on actions.

Resolution: Minutes of meeting held on Monday 10th June 2024 were approved as a true record with 2 abstentions. No actions are outstanding.

a) **24/01080/FUL** T & V Ingham, Cakewood Farm, Bath Road, Hungerford, RG17 0SR

Proposal: To make amendments to the extant consented scheme. Conversion of the cart shed and addition of mezzanine in the long barn

A representative of Cakewood Farm present confirmed that the conversion will be built with materials in keeping with the existing barns. The nesting owls are at the far end of the long barn and will not be affected by the development.

b) **24/01014/FUL** Mr Alfred Croft, Howard Hungerford Ltd & Fox Howard Ltd. 26 Charnham Street, Hungerford, RG17 0EJ,

Proposed: 1 x new dwelling and conversion and extension of existing buildings into 3 x residential units including associated landscaping to the rear of 26 Charnham Street, Hungerford.

WBC failed to make a decision in time by 17/1/24 (non-determination) resulting in this application being sent to the planning inspector. There is no change to the 2016 planning application. The build is being done sympathetically retaining architectural features. There is one objection from the public regarding parking however there is a full explanation of parking in the application.

Resolution: Strongly support. One abstention.

Comment: This development will benefit the town. HTC is disappointed about the long delay with this application particularly in view of the prompt development of the BMW and Mini garages.

Resolution: Objection. (5 in favour of objection, 2 against, one abstention)
Concerns voiced included: Street clutter, impact on footway and parking spaces, damage to paving slabs, doubt of effectiveness, cost and responsibility of maintenance. Over-engineering when alternatives exist such as shuttering, alarms, security fogging. Other locations in town are more in need of bollards for public safety.
