FGP202400111 Minutes - To approve and sign the minutes of the F & GP meeting on 13th November 2024.

FGP202400112 Receive an update on actions –

RFO will arrange one payment to be passed onto SUH up to the end of this financial year. Clerk has checked and the £2,000 Housing Needs Survey budget could come out of the existing NDP funds.

The Clerk has spoken to our insurers who confirmed employee helpers come under 'volunteers' and are covered for liability insurance. The approx. number of volunteers are disclosed at renewal and volunteers attend relevant training and are risk assessed.

The following actions are outstanding:

**ACTION:** Resolution: RFO to open an account with CCLA with a transfer from Barclays of £150k.

Money would be instant access through a Barclays account. Top up Newbury Building society with £15k and Nationwide with £10k. It was noted CCLA is not protected by FSA however it is widely used by other councils and by the diocese.

**ACTION:** Social Media Policy – Cllr Reeves is to review this.

All other actions are complete or underway.

FGP202400113 Consider costs for legal fees for Hungerford Shed and new allotments
