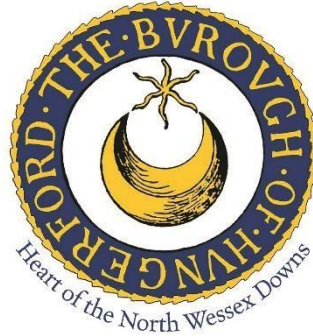

## **Draft MINUTES of the Extraordinary Meeting of the Full Council held on Monday 10<sup>th</sup> June 2024 at 6.45 pm in the Library, Church Street, Hungerford.**

**Present:** Cllrs Fyfe, Keates, Winsor, Knight, Alfred, Schlanker, Cole, Armstrong, Coulthurst & Montgomery.

The meeting opened at 6.45pm with Cllr Cole welcoming Cllrs.

**FC202400113 Apologies for absence** – Cllrs Simpson, Hudson, Carlson, Reeves,

**FC202400115** Consider a new Grant Application Request from Hungerford Guides & Brownies for funding from HTC and ratify payment of the award is successful

Cllr Cole requested DTC provide an update on the request from Hungerford Guides & Brownies. DTC confirmed that the guides and brownies would be camping in a 'tented village' with other guiding groups and whilst their parents/carers had paid for this, they were seeking additional funds so they could go on a cinema trip, a celebratory meal out or a visit to an animal centre. They were already fund raising by packing bags in the local supermarket, cake sale and selling bacon rolls at a local farmers market so were seeking additional funds.

Individual applicants, not applicable to go on The Good Exchange, had funding agreed and it was confirmed that the DTC would write to them separately to inform them.
