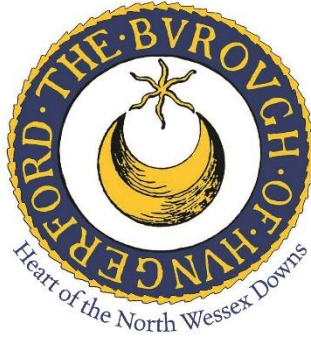

MINUTES of the **Full Council Meeting** held on Monday 2nd June 2025 at 7.00pm in the Library, Hungerford.

Present: Cllrs, Simpson, Reeves, Cole, Fyfe, Keates, Hudson, Carlson and Montgomery.

Also present: Representative from Penny Post and Newbury News, District Cllr Dennis Benneyworth (DB) from West Berks Council (WBC), and three members of public. Four members of Hungerford Resource Centre. Town Council solicitor.

In attendance: Town Clerk, (TC).

Below is the presentation from the Resource Centre which was read out at the meeting:

Why are we here?

We are here this evening to spread the word about the amazing and important activities happening at Hungerford Resource Centre

We have recently discovered through local engagement that a lot of the people we have spoken to are hearing about us for the first time and are uncertain about what we are, where we are and what the future is for our staff and customers.

What is a Resource Centre?

Hungerford Resource Centre is a purpose-built day centre dedicated to providing compassionate support to individuals who face unique challenges in their daily lives including physical, neurological and cognitive conditions, general health issues and those living with dementia or who are socially isolated.

People who use the service enjoy meeting with people and maintaining and developing functional, cognitive and social abilities and interests within the fun, inclusive environment that is nurtured by our highly trained team of staff. As well as meaningful daily activities that reflect the lifestyles and preferences of our customers, there are many socially stimulating activities, for example spending time in the community or joining an entertainer for a dance in the afternoon, helping them to achieve their social goals or simply enjoy the personal fulfilment of trying something new.

Why is it important for the customers who use the service?

Although there are other wonderful groups and services available locally, the level of care that Hungerford Resource Centre provides is unique. Staff are trained to deliver person centred care that supports customers all round wellbeing.

They work with families and carers of individuals to ensure that cultural customs are respected, skills and abilities are promoted and changes and challenges for each person are monitored and supported.

As a local authority service we are able to work collaboratively with other professionals involved in the care of our customers to promote responsive, holistic care to those we support.

Why is it important for the local community?

As well as directly benefiting those who attend, the centre also provides an opportunity for often much needed respite for carers and relatives.

With their significant person or people being safely looked after, people who occupy the role of carer have a chance to recharge batteries, maintain social connections and in some cases make time for work.

Through our activities our customers can maintain links with the community and the community can benefit from being involved in the activities we provide. For example, we have visits from school children, the church and numerous volunteers and entertainers and these interactions, as well as being hugely enjoyable for our customers are equally beneficial for the health of the community.

What does the future hold?

Many of you will know the West Berkshire Council voted at the end of February to look at different ways of providing our day services.

While this period of exploration is ongoing, we are keen to tell you all that the centre is operating business as usual and we urge anyone who knows someone who would benefit from this incredible service to contact us either directly or through adult social care for west berks.

Where are we?

Ramsbury Drive situated close to Hungerford Common and a short walk from the town centre.

It was commented that the title 'Resource Centre' does not perhaps clearly define what the organisation does. Whilst they can't change their name they do refer to themselves generally as a day centre. DB suggested that members of the Council may wish to have a tour of the centre. The Mayor added how much the facility was valued locally. Cllr Montgomery suggested a collaboration with Fairclose, which was welcomed. They already work with Greenfield and Phoenix House, and they do have transport facilities. Cllr Reeves remarked that the occupancy figures included in the consultation looked good. The Resource Centre confirmed that it had been a challenge with some days better than others. They have a capacity of 20. Other centres obtain over their capacity. They have had issues with communication and referrals taking a long time. Cllr Keates offered to put them in touch with a contact for digital inclusivity.

FC20250088 **Approval of Minutes of the meeting of the Full Council of 6th May 2025 and outcome of actions**

Resolution: Minutes of the meeting of 6th May 2025 were agreed as a true record. One abstention.

Outcome of actions:

Confirmation has been received from DG that she has diarised a site meeting a week before the 4th Sept 2025 to block off an area from vehicles so the volunteers can clear back the vegetation in Station car park. The loose and missing flints and bricks in the car park wall have been reported several times to WBC but they have no budget to deal with the improvements required.

DG has written to request a meeting with senior personnel at SNG (Sovereign Network Group) about the poor state of their garages and has emailed across our concerns.

ACTION: Await update from Sovereign on garages.

The response from Hungerford Carehome has been fed back to WBC and a further request to clear the verge to create escape areas for pedestrians from the traffic along the A338 has been sent.

We have been offered a couple of dates to meet with the North Wessex Downs representatives, 18th or 19th June in the morning. It was suggested HTC could meet at their office if it was easier.

ACTION: Councillors to let the office know which date they can attend the NWD meeting.

The Mayor advised that a key stake holder meeting about the loss of Hungerford's Sergeant is happening soon which she will attend with Lee Dillon MP, DG and Matthew Barber. DB will be unable to make the meeting but has made his views known.

ACTION: Await feedback following police meeting.

ACTION: Await feedback on repairs to bus stop on A338. DG is chasing.

FC20250089 Consider co-option of new councillors. There are currently four vacancies that can be filled by co-option. New councillors must sign a declaration of acceptance of office form before joining the meeting. All three candidates present gave positive feedback of the meetings that they had observed over the last month and were still keen to join. Councillors had no further questions.
Proposed: Cllr Simpson
Seconded: Cllr Montgomery
Resolution: Co-opt all three candidates, Nia Day, Jane Brunning and Simon Mulholland as councillors.
Each candidate signed their declaration of acceptance of office and joined the meeting.

FC20250099 Consider acceptance of the Licence to Sublet and Licence to Alter with reference to use of the Croft Field Centre by Hungerford Shed. *(This item was brought forward into Part 1 to allow questions to HTC's solicitor present)*
WBC is happy to give permission for the Hungerford Shed to operate at the Croft Field subject to the agreement of the above mentioned two licences. A sub-lease has also been drawn up which is based on the HTC/WBC lease. It was confirmed: -

- HTC wishes to retain flexibly concerning reinstatement in relation to building alterations.
- Installation of a separate electric meter and the registration fee both need to be paid for by the Hungerford Shed.
- The time period for insurance needs to be checked.
- A five year lease with a 2 year break clause is preferable.
- HTC wish to have confirmation of the name of the legal entity (Hungerford Shed??) as not in companies house, before agreements are signed.

Resolution: Delegate authority to the Mayor, Deputy Mayor and Clerk to finalise details of the paperwork with solicitor.

ACTION: Solicitor to email Hungerford Shed and copy in Clerk.

FC20250090 Receive Mayor's Report – Please see **attached report.**

FC20250091 Receive District Councillor's Reports – DB voiced his personal thanks to ex-councillor Rob Brookman who sadly passed away recently. Rob had previously chaired the H&T committee and had been heavily involved with the Christmas lights. DB commented on what a lovely person he was. Our thoughts are with his family. The Mayor will attend his funeral with other councillors that knew him.

DB advised WBC have received some requests from residents for 20mph limits and are keen to put up some limits. A few manholes have been fixed that were logged on 'report a problem'. Councillors mentioned that two cables, one outside 1 Bridge St and another on Atherton Rd are dangerous and are awaiting SSE to fix them. There is also a low hanging cable along the A338 near the carehome that the mayor has reported.

ACTION: DB will raise with the executive, that utility companies are letting WBC down.

It was noted that the Hungerford Park planning application has been deferred from the Western Area Planning meeting at the last minute. DB has been chasing for progress on the cleaning of the high street footway and Daniel Warne has been in touch with highways. It was requested that the cleaning takes place ahead of our Britain in Bloom judging day on 16th July. DB advised there are on-going problems with Bewley Homes and he will get back to us with an update.

FC20250092 Health & Safety – Receive any complaints or concerns. Cllr Keates reported that another delivery wagon has mounted the footway which not only causes damage but also means pedestrians have to

walk in the road. We can ask business owners to discourage their delivery drivers from doing this. Penny Post are happy to issue a statement from HTC regarding this.

The RFO's progress so far with obtaining prices was noted. Full details are still awaited from SSE. It was suggested multi-year contracts should be considered and a broker approached.

FC20250097 Receive any reports (no more than 3 minutes per report which cannot contain any proposals).

Cllr Montgomery left the meeting.

Cllr Cole reported that he attended the Heritage Forum on Thursday. There is a new conservation officer but unfortunately they did not attend. There was a discussion about the local listing process. Most of Hungerford town centre is Grade 2 listed. We can look at what else might need to be listed which is important as it affects the planning process. The forum are looking at restarting the process of redefining the Heritage Conservation area. A project manager is needed to put together a report. We wait to hear what the time requirements are for this.

It was noted that the Coin shop is being refurbished and the hoarding has been removed. WBC highways feel that planning has made a wrong decision on the bollards.

Cllr Hudson advised that Regulation 16 Consultation has completed. 46 comments were received which although higher than most is not surprising as the Hungerford Neighbourhood Plan is allocating planning. The comments were relating to the two planning sites, and these will now go to Andrew Mead the inspector who has local experience of West Berks. The inspector will modify and potentially there could be an examination in public. It was noted that Whitchurch Town Council had written with their support.

Cllr Reeves has read the financial benefits of the Aldi planning application and encourages everyone to read them. He thinks the store would be of huge benefit to the town.

Members of press and WBC left the meeting.
